The **OBAPACE Academy** is designed to provide a more in-depth look at the aviation industry for students who truly want to continue their dreams. This program will provide a more in-depth classroom discussion, field trips to aviation related entities, to include college/universities, hangars, towers and possibly small airplane flight. The target age group is middle to high school students, target ages 14-17 years. Each academy capacity is approximately 30 students.

The **OBAP Solo Flight Academy** allows students from across the country, varying in age, to embark upon two weeks of being fully submerged in aviation training, the outcome, to solo an airplane for the very first time. See the website or brochure for additional information.

There is a non-refundable application processing fee of \$20.00. The fee is payable via credit card if the online application process is used. ANY ADDITIONAL FEES WILL BE COMMUNICATED BY THE ACE or Solo Flight Academy Program Director. The fee is payable via check or money order if you are mailing this application. Mailing your application and fee will take longer to confirm academy acceptance. Your check must be cleared before acceptance.

TSA Citizenship Requirements

Any U.S. citizen applying for training to be used towards a **recreational, sport pilot, private pilot (single or multi-engine) certificate, multi-engine rating at any level, or instrument rating**, in an aircraft weighing less than 12,500 pounds must present the flight school or flight instructor with evidence of **U.S. citizenship**. Evidence may be shown by **one** of the following.

1. A valid unexpired U.S. passport
2. An original birth certificate of the United States, American Samoa, or Swains Island, and government-issued picture ID
3. An original U.S. naturalization or citizenship certificate (Form -550 or -570) with raised seal and government-issued picture ID
4. An original certificate of U.S. citizenship with raised seal (Form -560 or N561), or a Certificate of Repatriation (Form -581), and government-issued picture ID
5. An original certificate of birth abroad with raised seal (Form FS-545 or DS-1350) and government-issued picture
